Definitions		
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include companies with a NBKC Bank name. 	
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Nonaffiliates we share with can include companies, such as direct marketing companies, insurance companies, non-profit organizations and mortgage companies. 	
Joint marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include companies, such as real estate service provider and credit card companies. 	

Other important information

You may have other privacy protections under applicable state laws. To the extent these state laws apply, we will comply with them when we share information about you.

For California residents: In accordance with California law, we will not share information we collect about you with companies outside of our corporate family, except as permitted by law, including, for example with your consent or to service your account. We will limit sharing among our companies to the extent required by California law. Please see the separate notice you are receiving entitled California Consumer Privacy Act for a full description of your rights.

For Vermont residents: In accordance with Vermont law, we will not share information we collect about you with companies outside of our corporate family, except as permitted by law, including, for example with your consent or to service your account. We will not share information about your creditworthiness within our corporate family except with your authorization or consent, but we may share information about our transactions or experiences with you within our corporate family without your consent.

FACTS

If you are a California Consumer, as such term is used in the California Consumer Privacy Act ("CCPA"), you have certain rights to make requests relating to personal information we collect about you. Notice	You have the right to be notified of what categories of personal information will be collected at or before the point of collection and the purposes for which they will be used and shared.	
Access	You have the right to request information on the categories of personal information that have collected in the previous twelve (12) months, including:	
	 the types of sources from which the personal information was collected, 	
	the specific pieces of personal information we have collected about you, and	
	• the business purposes for which such personal information is collected and shared.	
	You also have the right to request information of the categories of personal information which were disclosed for business purposes, and the categories of third parties for the twelve (12) months preceding your request for your personal information. The law prohibits us from any form of discrimination as a result of your request(s) for information.	
Data Portability	You have the right to receive the personal information you have previously provided to us.	
Deletion	You have the right to request deletion of data. We collect and retain only the information that we need to meet legal and regulatory requirements, maintain your accounts and serve your financial needs. As a result, we may not be able to delete information due to a legal or operational need to retain it.
